 - Qn re the management of waste reference here to noise coming from local businesses when disposing of waste.
 - so impact on local residences noise, waste, staff behaviours etc
 - Andrew S gave examples of how once the CoF has been made aware of issues (if not pre-empted) that the business is asked to develop a management plan to minimise impacts.
 - Qn- how to apply for speed bumps in minor streets (eg, Little Lefroy). Suggestion from CoF and councillors is to approach the issue from a collective perspective can send queries/questions to the precinct for collation and sending to CoF
 - Can revisit the idea of a "traffic calming working group" any interested attendees are welcome to advise the precinct
 - NB: residents encouraged to lobby local MP re traffic/car speed concerns
 - NB: the below additional questions were put to Glen (CoF) after the meeting by Andrew Sullivan (with additional comments in red font by Sean Hefferon):
 - 1. Will there be (can there be?) a commensurate increase in the policing of parking in South Fremantle to coincide with greater restrictions. Bug bears are overstayers, parking in front of driveways, parking too close to intersections and in no-standing zones;
 - 2. There may need to be improvements in line marking and signage to better distinguish where parking is permitted.
 - 3.Do we have a simple Q&A type sheet or pamphlet that can give locals a heads-up about the most common parking issues and the right processes to deal with them, including relevant staff contacts etc. If not, it could be a good idea to develop one. Could this be available by the 9/5??
 - 4.Speed humps on South Terrace most locals favour them, and were disappointed when some were removed. The long gap between humps south of Scott Street is a spot where fast speed still prevails. Suggestion was to reinstate some of the humps. Could the

- 5. Speed humps that allow drivers to constantly deviate around them, typically by swerving towards the left, are of particular ongoing concern. (I have previously raised this on several occasions without any response or action). The common view amongst locals is to put a second hump between the kerb and existing hump; It would be good to have an update on what can be or will be done on this specific matter.
- 6.Request for an update about traffic counts and speeds along South Terrace please provide info on what has been recorded to date; Could this be available by the 9/5 community event?
- 7. Provide an update on the strategy to lower the posted speed limits, including whether we have applied to lower the speeds; again helpful info to publicise at the event.
- 8. Will an Operational Management Plan be developed for the proposed brewery within the Sealanes site, to deal with noise, smells, etc.
